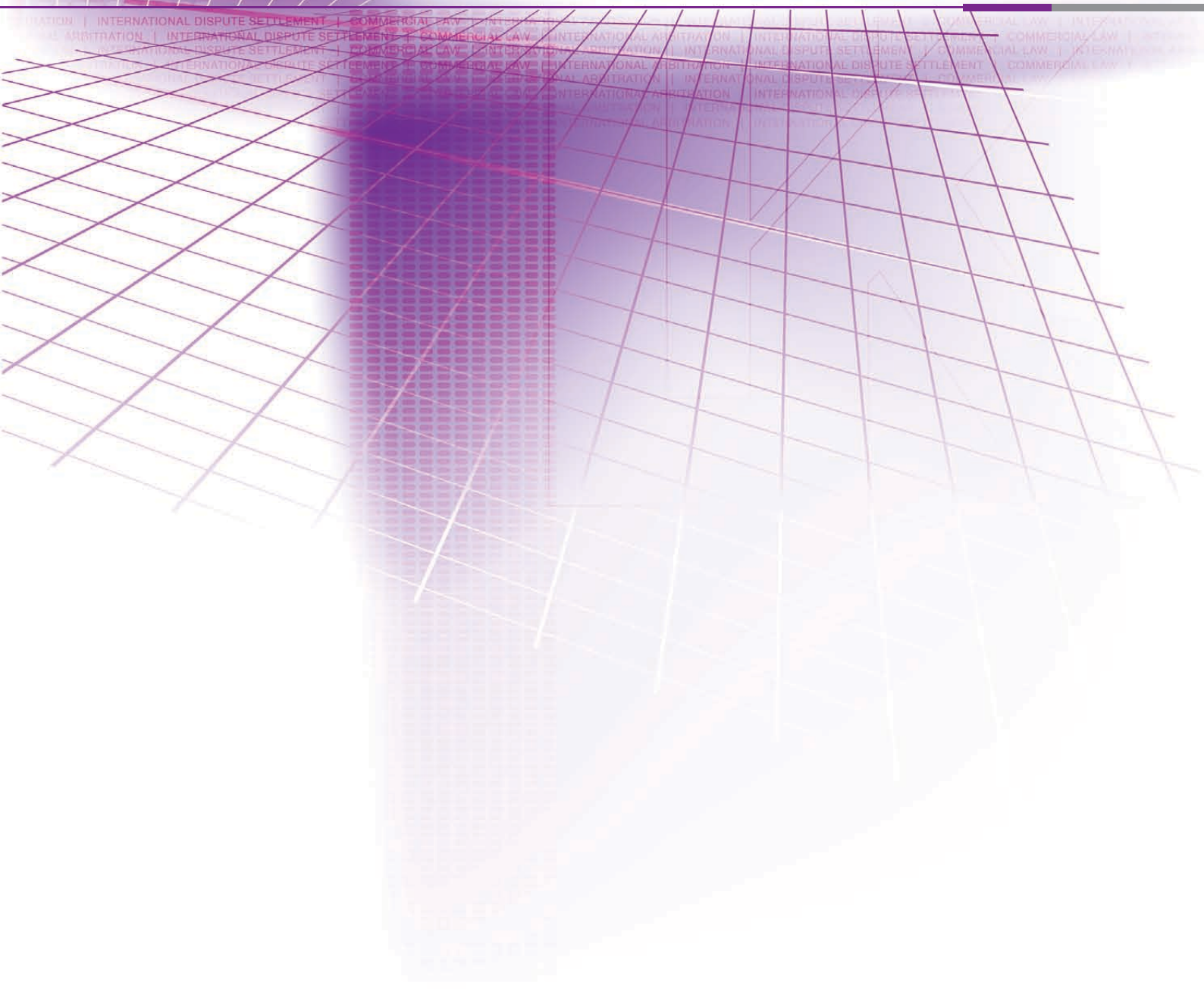

## International Arbitration

---

Of Swiss parentage, Phillip was raised in Canada. He qualified and practiced as an Ontario lawyer before moving to Cambridge, England, Ferrara, Italy, and Freiburg i. B, Germany to conduct research and write a doctoral thesis on civil law obligation.

His subsequent legal practice of over ten years in international arbitration, mostly in Geneva, but also in London, and for three years in EU competition law in Brussels builds on his combined common law and civil law foundation. He is qualified as an *avocat* (*Geneva*), a solicitor (*England & Wales*) and a barrister & solicitor (*Ontario*). Phillip trained in common law chambers at the English bar to obtain daily court room experience in the skills of oral advocacy. In his years at a Magic Circle English law firm, Phillip acquired the practical skills of managing large international cases. Additionally, his seven years at leading Swiss international arbitration firms fully acquainted him with the techniques and view points of Swiss arbitration practice, and the Swiss international arbitration community.
